Question 15: The Organization had flood damage at its Las Vegas location during the year and as a result it abandoned building improvements with a net book value of \$142 (Cost: \$49,758 less A/D: \$49,616) and furniture and equipment with a net book value of \$0 (Cost and A/D: \$13,268). Furthermore, the Organization sold their Santa Maria building during the year with land and furniture included in the sale. The sales price of these assets has been allocated entirely to the building on
