United Technicians do not forget to get Your IBT Transfer or Withdrawal Card

If you are a United Technician facing furlough or being displaced in the Reduction in Force you must put in for your transfer or withdrawal card per the IBT Constitution or face a re-initiation fee when you transfer to a new station or if you return from furlough. IBT Locals will impose re-initiation fees on members who fail to apply. Junior United Techs are some of the lowest paid in the industry with the longest pay progression.

We are providing this information to help our junior and displaced technicians avoid re-initiation fees levied against them by Teamsters locals.

[\\$500.00 dollars at Local 19 IAH](#) this is the Re-initiation fee charged by Bob Clever's Local.

[\\$250.00 dollars in Denver Local 455](#) for the United Techs being furloughed or bumped from Denver.

[\\$150.000 dollars in CLE IBT Local 964](#) for United Techs furloughed or bumped in the Heart of Rock & Roll.
