**Proposed Amendment to the Constitution and Bylaws of Local 210,
International Brotherhood of Teamsters**

WHEREAS Section 19(A)(1) of the Local Union Constitution and Bylaws currently provides for monthly general membership meetings; and

WHEREAS the Local Union Executive Board believes that monthly general membership meetings are no longer practical because of the regular craft meetings held by and on behalf of large segments of the general membership; and

WHEREAS it is the sense of the Local Union Executive Board that given the large geographic area covered by the Local Union's charter, it would be a hardship for members located outside the New York City Metropolitan area to continue to hold general membership meetings on a monthly basis; and

WHEREAS it is also the sense of the Local Union Executive Board that holding general membership meetings on a quarterly basis will better serve the Local Union's membership and provide a more efficient forum for members to exercise their rights as provided by the Local Union Constitution and Bylaws;

IT IS HEREBY PROPOSED THAT SECTION 19(A)(1) OF THE CONSTITUTION AND BYLAWS OF LOCAL 210, INTERNATIONAL BROTHERHOOD OF TEAMSTERS BE AMENDED TO PROVIDE AS FOLLOWS:

(A) General Membership Meetings

- (1) General membership meetings shall be held quarterly at such place and time as shall be designated by the Local Union Executive Board subject to disapproval by the membership. The time and place of meeting in effect when these Bylaws are adopted shall continue until changed by the Local Union Executive Board upon reasonable and adequate notice to the membership. Membership meetings may be suspended during any three months between June and October by action of the membership at a meeting after reasonable notice of the intention to vote upon such question.
